RESOLUTION NO. 19-7215

A RESOLUTION OF THE CITY COUNCIL OF HERMOSA BEACH, CALIFORNIA, AMENDING THE MASTER FEE SCHEDULE TO INCLUDE ADMINISTRATIVE FINES FOR VIOLATIONS OF CHAPTER 12.36 OF THE HERMOSA BEACH MUNICIPAL CODE (TREES)

THE CITY COUNCIL OF THE CITY OF HERMOSA BEACH DOES RESOLVE AS FOLLOWS:

Section 1. Recitals.

1. Upon adoption of Ordinance No.19-1397, violations of the City's tree ordinance, Chapter 12.36 of the Hermosa Beach Municipal Code ("HBMC"), will be subject to the procedures for administrative citations and penalties set forth in HBMC Chapter 1.10.

2. Pursuant to Section .050 of HBMC Chapter 1.10, persons issued an administrative citation will be subject to a fine as set forth in a penalty schedule adopted by resolution of the City Council.

Section 2. The schedule of administrative fines for violations of HBMC Chapter 12.36 shall be as follows:

A. Violations of HBMC sections 12.36.050 (Damage, Destruction, or Removal of Parkway Trees) and 12.36.060 (Permit Required for Parkway Tree Removal) are subject to fines in the following amounts:

1. \$250 for a first violation.
2. \$500 for a second violation within one year of the first violation.
3. \$1,000 for each additional violation within one year of the first violation.


These penalties are in addition to any applicable replacement costs for a parkway tree that may have been destroyed by the cited party, as set forth in HBMC Section 12.36.100.

1 **B. All other violations of HBMC Chapter 12.36 are subject to fines in the following**
2 **amounts:**

- 3 **1. \$100 for a first violation.**
4 **2. \$200 for a second violation within one year of the first violation.**
5 **3. \$500 for each additional violation within one year of the first violation.**

6 **Section 3. The Mayor shall sign and the City Clerk shall attest to the passage**
7 **and adoption of this Resolution and enter it into the book of original resolutions.**
8 **This Resolution shall take effect concurrently with the effective date of**
9 **Ordinance No. 19-1397.**
